ROBERT FATHMAN – 5805 TARTON CIRCLE NORTH

My wife and I have lived in Muirfield for 22 years and have been involved in many ways. For the past several years I have chaired the Civic Action Committee of the Muirfield Village Civic Association, a group that successfully pressured AEP into spending \$14 million upgrading electric service in Muirfield. The “Muirfield List” and the “Update Your Home” seminars also arose from this Committee.

In my position as a Director of the Homeowner’s Association, I have been an advocate not just for keeping Muirfield up to date, but for advancing it *ahead* of newer subdivisions with improvement to facilities, landscaping and the website. I have supported pool improvements, the splash park, water slide and new hot tubs. Spending on bike path maintenance increased, the playsets were significantly upgraded and the putting green was added. The Association has upgraded landscaping for Muirfield neighborhood entrances, added stone walls, new flowers and irrigation systems where water is available. Changing legal representation has resulted in vastly improved collection of past-due accounts and better compliance with deed requirements. We recently began a successful program allowing residents to memorialize loved ones with a tree, bench or swing.

Trustees need to look forward, and not just be content with the past. I want Muirfield to be the place where your home value increases, and where your children and grandchildren will return to live. As you consider candidates, I hope you will support the efforts I’ve made to move Muirfield forward financially, aesthetically and with improved facilities.
